MINUTES: 2016 PGSG BUSINESS MEETING

Thursday, March 30, 2016, 7:10 pm Union Square 21, Hilton Hotel, 4th Floor

II. Preconference report & budget

The pre-conference was held on Monday, March 28 in the Nikko Hotel (222 Mason St.), one of the main AAG conference hotels this year.

We had 88 people signed up for the conference ahead of time (almost all presenters, but a few organizers, chairs, and attendees). Actual registration was 88 people, including 46 paying non-student members for a total registration fee income of \$920. 51 people signed up to attend the dinner at King of Thai (184 O'Farrell St.).

After income and expenses from the preconference, as well as student awards, we should have \$1,593.31 in the PGSG budget.

V. Highlights from AAG Chairs Luncheon

AAG dispersed approximately \$50,000 in student awards this year.

AAG will lower dues in the lower-budget category to \$65.

The AAG meeting this year has some 9,000 attendees, with 126 sessions sponsored by PGSG.

VI. Discussion on Preconference format to deal with size/time constraints

Given that was this year's preconference was the day after Easter, it proved to be problematic and expensive to find a local host institution. Meanwhile the AAG had plenty of free rooms available that day so we took advantage of that opportunity. Unfortunately we did not realize until the day of the event that we had to pay \$400 per room (i.e. \$800 total) for audio visual set-up. At the last minute, the AAG conference company agreed to split that cost with us.

Discussion followed:

- convenience of the conference hotel vs. support of and opportunity to visit a local host institution

- number of simultaneous sessions; more sharing and large audiences vs. fitting more presentations in
- moving deadline up to December 1 to match when AAG abstracts are due
- bring back a common plenary and more preconference-wide activities if we have to stay with at least some concurrent sessions
- given that if one is attending the pre-conference AAG can make for a very long conference it was suggested that we request Oscar Larson to shift PGSG member's presentations to early in the week when possible
- the Board will incorporate many of these suggests in planning for next year's preconference to be held on Tuesday, April 4 in Boston. The AAG meeting itself will be held Wednesday-Sunday April 5-9.
